

# REEL OF FORTUNE – Size Matters \$100K

## INTRODUCTION

1. These Terms and Conditions (“**Terms**”) apply to the Reel of Fortune – Size Matters \$100K promotion (“**Promotion**”), part of Season 11 of the Million Dollar Fish competition (“**Competition**”). Information on how to enter (including on the Website) and prize details form part of these Terms.
2. Participation in this Promotion is deemed acceptance of: (a) these Terms; and (b) the Million Dollar Fish Season 11 Competition Participants’ Terms and Conditions (“**Main MDF T&Cs**”), available here: [Terms and Conditions](#).
3. Capitalised terms and expressions in these Terms have the same meaning as the in Main MDF T&Cs, unless defined otherwise herein.

## PROMOTER

4. NTMEC is the Promoter (“**Promoter**”).

## PROMOTION PERIOD

5. The Promotion commences at 12:00am Australian Central Standard Time (“**ACST**”) on Sunday 1 March 2026 and will continue until 11:59pm ACST on Tuesday 31 March 2026 (“**Promotion Period**”).

## ELIGIBILITY

6. Participation in the Promotion is open to all Australian residents aged 18 or over who are registered for Million Dollar Fish Season 11 Competition prior to the Promotion Period commencing (“**Eligible Entrants**”).
7. Employees, agents, and Family Members of the Promoter and Promotion Partners are ineligible to participate.
8. The Promotion is subject to the Main MDF T&Cs and all applicable laws and regulations.

## HOW TO PARTICIPATE IN THE PROMOTION

9. To participate and win, an Eligible Entrant must be registered for Million Dollar Fish Season 11 and catch a verified Minor prize – being a *Season 11 red-tagged barramundi* worth AUD\$10,000 – during the Promotion Period (“**Winner**”).
10. Subject to rule 12 below, only one (1) Winner will be confirmed for the entire Promotion Period. Once a Winner has been verified in accordance with the Prize Claim Verification process at the end of the Promotion Period, the Promotion closes (after which the Competition resumes per normal).
11. This Promotion is a game of skill and chance plays no part in determining the winner.

## PRIZES AND NOTIFICATION

12. An Eligible Entrant that catches the largest \$10,000 red-tagged fish – in length, not weight – from season 11 by 11:59pm on Tuesday 31 March 2026 will be awarded the minor Cash Prize of \$10,000 plus an additional or “bonus” cash prize of \$90,000, together totalling \$100,000 (**Promotion Prize**). If at the end of the Promotion Period two or more Winners have caught the largest \$10,000 red-tagged fish from season 11 which is exactly the same

size, the Promoter will split the \$90,000 cash bonus equally, unless the Promoter determines otherwise in its sole and absolute discretion

13. This Promotion excludes any Major prize tagged fish worth \$1 Million Dollars. For the avoidance of doubt, a Winner cannot also win prizes in other monthly Promotions forming part of the Competition.
14. The Prize is not transferable, refundable or exchangeable.
15. The Prize Claim Verification requirements in section 26 of the Main MDF T&Cs apply.
16. The Promoter may, at its discretion, amend the Prize or any of these Terms.
17. The Winner will be announced on the Competition Facebook and Instagram pages after verification.

18. By participating in the Promotion, the Winner consents to the Promoter using their name, image, and likeness for promotional purposes without any compensation.
19. The Winner agrees to participate in all media and editorial activities relating to the Promotion and to cooperate with the Promoter. The Winner agrees to grant the Promoter a perpetual, irrevocable, royalty-free licence to use resulting materials for marketing, publicity and other purposes related to the Competition and Promotion.

20. The Promoter accepts no responsibility for late, lost, or misdirected entries.
21. The Promoter is not liable for any loss, damage, or injury (including but not limited to indirect or consequential loss) sustained in connection with this Promotion.
