

BASSINTHEGRASS ReFresh Upgrade Competition.

CONDITIONS OF ENTRY

- Information on how to enter and prizes form part of these Conditions of Entry. Entry into the promotion is deemed acceptance of these Conditions of Entry. This is a game of chance.
- Promoter: Northern Territory Major Events Company Pty Ltd (NTMEC) is the promoter.

ELIGIBILITY

- Entry is only open to residents of Australia ("Entrants"). The directors and management of the Promoter, its related suppliers, contractors and agencies whom are directly associated with the conduct of this promotion are ineligible to enter the promotion.
- 4. Entries are only open to people aged 18 years and above. All Entries (as that term is defined below) of Entrants who are under the age of 18 years and enter the promotion without disclosing (or who attempt to conceal) their age (as and where required) will be deemed invalid.

PROMOTIONAL DATES

 The Promotion commences at 12:01am Australian Central Daylight Savings Time on 19 December 2025 (if you have purchased an eligible ticket before then you will be automatically entered in the Draw to win the Prize) and closes at 11:59 pm Australian Central Standard Time on 31 December 2025. ("Promotion Period").

HOW TO ENTER

 - (a) Purchase up to four (4) General Admission Tickets to BASSINTHEGRASS in one transaction during the promotional period.
- 7. Each eligible transaction will be entered into the Draw to win a prize.

- 15. The winner will be sent the details on how they redeem their prize via email.

- 17. Winner will be notified in writing via email and by phone. The Promoters' decision is final and no correspondence will be entered into. The Promoter reserves the right to request the Entrant produce (within the requested time) appropriate photo identification or other documentation (to the Promoter's satisfaction, at its sole discretion) in order to confirm the Entrant's identity, age, residential address, eligibility to enter and claim a prize,

The Promoter, its associated agencies and companies excludes all liability (including negligence) except for any liability that cannot be excluded by law (including the Non-Excludable Guarantees), for any direct or indirect injury, loss and/or damage arising in any way out of the promotion.
