



### Promotion Terms and Conditions:

#### The Promotion

1. Australian Bullion Company (NSW) Pty Ltd (**ABC Bullion**) is conducting a trade promotion for its Gold Saver product and other products and services (**Promotion**) for individual (**Entrants**).
2. The Promotion is a game of chance and prize winners will be selected at random via an electronic draw from all valid entries received during the promotion.
3. Entries to the Promotion open on 1<sup>st</sup> July at 12am and close at midnight on 31 July 2025 (**Promotion Period**).
4. The Promotion draw will take place electronically on 1 August 2025.
5. Entry into the Promotion is deemed acceptance of these Terms and Conditions.
6. The Promotion is governed by and conducted in accordance with the laws of New South Wales.

#### Eligibility

7. Entry is open to Australian residents aged 18 years or over who are registered clients of ABC Bullion (**Clients**) except employees and immediate family members of ABC Bullion and any of its related bodies corporate.
8. Clients that open an ABC Bullion Gold Saver account and make their first investment in that product during the Promotion Period will automatically be entered into the Promotion.
9. Clients with an existing ABC Bullion Gold Saver account will automatically be entered into the Promotion.
10. Clients can only enter the Promotion once.

The legal rights of ABC Bullion to recover damages or other compensation from such an individual are reserved.
22. In the event the Promotion is compromised by tampering or other causes beyond the reasonable control of ABC Bullion, that corrupt or impair the administration, security, fairness or proper operation of the Promotion, ABC Bullion reserves the right to suspend, modify or terminate the Promotion.

  - (a) any and all disputes, claims and causes of action arising out of or in connection with the Promotion and the prizes shall be resolved individually without any form of class action;

Any disclosure of such information will be made as required by law and in accordance with these Terms and Conditions but no further use of this information will be made without prior consent.
